Gender issues:The issue of gender equality are best portrayed in poetry, drama and novels such as Wuthering Heights, Candida, Theories of Feminism, Stories of Premchand, Kashinath Singh and dramas of Jaishankar Prasad. Reservation policies, Constitutional Provisions specially for women are covered in Political science, Sex ratio, Education of child mortality, Water scarcity. Drought, Flood, Pollution, Urbanization and Modernization are practically unveiled through History, Economics, Psychology, Philosophy.

Environmental issues:For environmental science there is a separate

and compulsory paper in which a comprehensive project report is prepared on the surrounding area. Students are motivated to work for environment protection through NSS/NCC.

Human values: Human values are covered in curriculum of Political science, Economics, History, Hindi, English and B.COM Program.

Apart from the prescribed academic syllabus, NCC and NSS unit of the college actively participate in the national flagship programs and address crosscutting issues at community level. College arranges enough awareness programme on the hygiene and sanitation about the health in girl students.
